The complaint was surveyed on 12/22/2020. An entrance conference was conducted with Facility Representatives at 11:40 AM. The Facility Representatives were informed the purpose of the visit was to conduct a complaint survey. At that time the complaint was reviewed.

The Complainant was received through the Arkansas Department of Health online complaint at PM and alleged: "I was at the Little Rock Family Planning abortion mill this morning at The dad spoke to me coming from (Named City) and told me they had already tried to have an abortion in (Named City) but were denied because he said the reason for aborting the baby was a suspected disability of trisomy 18. I know for a fact doctors make mistakes as this past fall we had a mother sidewalk counseling alongside us who's Dr. also insisted abortion for her trisomy 18 baby except this mom chose life and her baby was absolutely healthy and well as she had the child present doing sidewalk counseling. This morning this dad (Named) brought his girlfriend (Named Patient) to kill their baby at 22 weeks age. This dad told me they came yesterday (which I have two I witnesses that saw him, (Two Named Persons)) and had the abortion at 8:30 AM today. This violates the 72 hour waiting period as stated by Arkansas Law as well as being passed the legal gestational age in Arkansas at 22 weeks. I believe the reason the abortionist did not do the 72 hour waiting period is because he already knew the baby was too far along.

(Named Person) told me his girlfriend (Named Patient) and him named the baby (Named Patient) and that they came to Little Rock Family Planning Clinic because it was the only abortion mill they could find that would do this abortion after being denied in (Named State).

I strongly encourage a surprise inspection of the Little Rock Family Planning facility before noon on the Little Rock Family Planning. There is a mole at the Dept Of Health who tips off Little Rock Family Planning far in advance of any inspections so it would need to be done through the attorney generals office or someone else of more confidence at the ADH.

The room to look for would be labeled "POC" meaning products of conception and as the workers jokingly say parts of children room. I strongly insist and believe that finding this "POC" room and locating baby (Named Baby)'s body parts will clearly show laws broken here in Arkansas.

The truck driving on from (Named City) picks up the baby body parts so it would absolutely be imperative the inspection occur before that happens. This is very much another (Named Facility) abortion facility where laws are broken and babies lives are ended. Please call me at [Listed phone #] to speak to me directly about what occurred this morning. Godspeed."

Complaint findings.

An interview was conducted with Agency Personnel #1 on 12/22/20 at 11:45 AM. They provided the following document the facility utilizes guidance from the National Abortion Federation titled "National Abortion Federation Clinical Policy Guidelines, December 2017" as the policy for the process for determining gestational age.

Review of 31 clinical records showed no abortion procedure, medical or surgical, occurred after 20 weeks gestational age.

Review of 31 clinical records showed no abortion procedure, medical or surgical, occurred prior to the 72-hour timeframe.

There was no evidence any abortion procedure was performed outside the required timeframes.

An exit conference was conducted with Facility Representatives on 12/22/2020 at 12:40 PM. The complaint was not substantiated. Deficiencies were not cited. State Agency recommends no further action.
