DEFENDANT STATE OF ARKANSAS' NOTICE OF APPEAL

Comes now Defendant, State of Arkansas, by and through Attorney General Leslie Rutledge and Assistant Attorney General Sammie P. Strange, Jr. and hereby gives notice of its appeal to the Arkansas Supreme Court pursuant to the Ark. R. App. P. Civ. 2(a)(6) and 3(b). State of Arkansas states as follows:

- 1. **Appealing Party.** State of Arkansas is the appealing party.
- 2. **Order Being Appealed.** State of Arkansas appeals from the order of the Pulaski County Circuit Court: Order for Declaratory Relief and Preliminary Injunction on August 6, 2021.
- 3. **Designation of the Record.** State of Arkansas designates the entire record in this matter as the record on appeal—including all pleadings, amended pleadings, motions, exhibits to the motions, supporting briefs, responses, replies, orders, and the transcripts of the hearing held in this case on August 6, 2021. State of Arkansas requests an electronic record pursuant to *In re Acceptance of Records on Appeal in Electronic Format and Elimination of the Abstracting and Addendum Requirements*, 2019 Ark. 213.
- 4. **Certificate of Transcript.** Pursuant to Ark. R. App. P. Civ. 3(e)(iv), State of Arkansas has ordered the transcript of the August 6, 2021 hearing, and made all financial arrangements required by the court reporter.
- 5. **Jurisdiction of the Arkansas Supreme Court.** State of Arkansas takes this appeal to the Arkansas Supreme Court, which has appellate jurisdiction in this matter pursuant to Ark. R. App. P. Civ. 2(a)(6).
- 6. **Abandonment of Claims.** State of Arkansas has not asserted any claims against a party in this matter, and so Rule 3(e)(vi) of the Ark. R. App. P. Civ. does not apply here.

WHEREFORE, State of Arkansas prays that the Court accept its Notice of Appeal, and prays for all other just and appropriate relief.
