

The Proposed Platform of the Republican Party of Arkansas is amended by adding an additional paragraph at the end of the **Education Reform** section to read as follows:


"We oppose the sexualization of school children including the introduction of sexually explicit materials and instruction and the introduction of gender choice materials and instruction into schools."

"We oppose the teaching of Critical Race Theory (CRT) and any other similar teaching that promotes racial disunity, racial superiority and/or racial inferiority and anti-American rhetoric. We oppose the teaching of Socialist, Communist, and Marxist ideology."




PLATFORM AMENDMENT TO SUPPORT A CLOSED PARTY PRIMARY.

The Proposed Platform of the Republican Party of Arkansas is amended by adding an additional paragraph following the paragraph which says, "By the will of Arkansas's citizens, the Republican Party of Arkansas is the **majority party in our state** and has therefore been given the responsibility to set policies that reflect this will."

The new paragraph to be added reads as follows:

"Due to ongoing efforts by Democrats to influence the Republican Party primary through calls for cross over voting and candidates, we support the revision of Arkansas election laws and Party rules to establish a closed party primary."




PLATFORM AMENDMENT TO SUPPORT PARTISAN JUDICIAL ELECTIONS.

The new paragraph to be added reads as follows:




"We oppose mandatory COVID-19 vaccinations in the workplace and oppose the termination of employees for refusing such vaccinations."

The Proposed Platform of the Republican Party of Arkansas is amended by adding an additional paragraph at the end of the **Education Reform** section to read as follows:


"We support the protection of women's sports and applaud the Arkansas General Assembly for prohibiting genetic males from participating in women's sports."



PLATFORM AMENDMENT TO SUPPORT UPDATING ELECTION LAW TO PROTECT AGAINST CYBERSECURITY THREATS.

The Proposed Platform of the Republican Party of Arkansas is amended by adding an additional sentence at the end of the paragraph which says, "*We support the efforts of county election commissioners to modernize voting equipment used in our elections in order to protect against voter fraud of any kind.*" The new sentence to be added reads as follows:

"We support updating Arkansas election law to require robust cybersecurity, in-State housing of election data, full computer forensic imaging of the pre-election and post-election equipment and poll books, post-election physical count of the number of voted ballots to assure the total count equals the total number of reported votes, and the immediate release of all post-election data to allow for data analysis and public canvass before certification."



RULES AMENDMENT TO SUPPORT BEING A REPUBLICAN TO VOTE IN THE REPUBLICAN PRIMARY.

The Rules of the Republican Party of Arkansas are amended by inserting the following words, "Qualified electors shall be registered as a Republican to vote in the Republican Party primary election." into Article I General Provisions Section 5 — Primary Elections as item B.


Rule Before Amendment: Article I General Provisions Section 5 – Primary Elections

- A. The Republican Party in each county shall hold a primary election in every evennumbered year.
 - Except for support of candidates in a presidential preferential primary, the State Chairman, National Committeeman, National Committeewoman, District Chairmen, County Chairmen, County Election Commissioners (per State Statute), State, District or County Committee or State Party employees shall not endorse or otherwise publicly show favoritism to one Republican candidate over another prior to the Republican nominee being elected. State Executive Committee and/or the respective County Committees, by a two-thirds (2/3) vote of the members present at any regular or duly announced special meeting may vote that a particular candidate is not recommended.
 - 2. If a person holding any of the above named Party positions should become a candidate in a contested Party Primary election, he or she shall within three (3) business days either resign the Party Office or withdraw from the candidacy.
 - 3. In accordance with State Law the State Committee, in the case of Federal, State and District candidates, and the County Committee, in the case of all other candidates, shall be responsible for determining the qualifications of candidates seeking nomination by the Republican Party, provide necessary applications for candidacy, accept and process the applications and determine the order of its ballot, in accordance with state law. They shall file all required certifications with the State or County Secretary, Secretary of the State, or their respective County Clerk in a timely fashion, in accordance with state law.

Rule After Amendment: Article I General Provisions

Section 5 – Primary Elections

- A. The Republican Party in each county shall hold a primary election in every evennumbered year.

 - B. Qualified electors shall be registered as a Republican to vote in the Republican Party primary election.



RULES AMENDMENT TO SUPPORT BEING A REPUBLICAN TO RUN REPUBLICAN.

The Rules of the Republican Party of Arkansas are amended by inserting the following words "<u>be registered as a Republican</u>," after the words "Republican Party of Arkansas," into Article I General Provisions Section 4 — Candidates for Public Office A.

Rule Before Amendment:

Article I General Provisions

Section 4 – Candidates for Public Office

A. A candidate who possesses those qualifications required by the laws of Arkansas and the United States of America, shall affirm his or her concurrence with the principles and objectives of the Republican Party of Arkansas, and pay the prescribed filing fees.

Rule After Amendment:

Article I General Provisions

Section 4 – Candidates for Public Office

A. A candidate who possesses those qualifications required by the laws of Arkansas and the United States of America, shall affirm his or her concurrence with the principles and objectives of the Republican Party of Arkansas, <u>be registered as a Republican</u>, and pay the prescribed filing fees.
